Location: Fairfield is centrally located in Northern California and is approximately 45 miles from both the San Francisco and Sacramento airports, and approximately 48 miles from the Oakland airport. It is the home of Travis Air Force Base and the Jelly Belly

Factory (a jelly bean factory, which offers free tours). In addition, the hotel is located near the Westfield Mall, which houses a theatre and several restaurants are in the general vicinity. Approximately 14 miles west of Fairfield is the Six Flags Discovery Kingdom theme park, located in Vallejo, California. Last but not least, there is a lot to see and do in world famous San Francisco, as well.

<u>Friday Night Live</u>: In lieu of a banquet, the California planning committee has decided to have a buffet style dinner on Friday, July 16, 2010.
